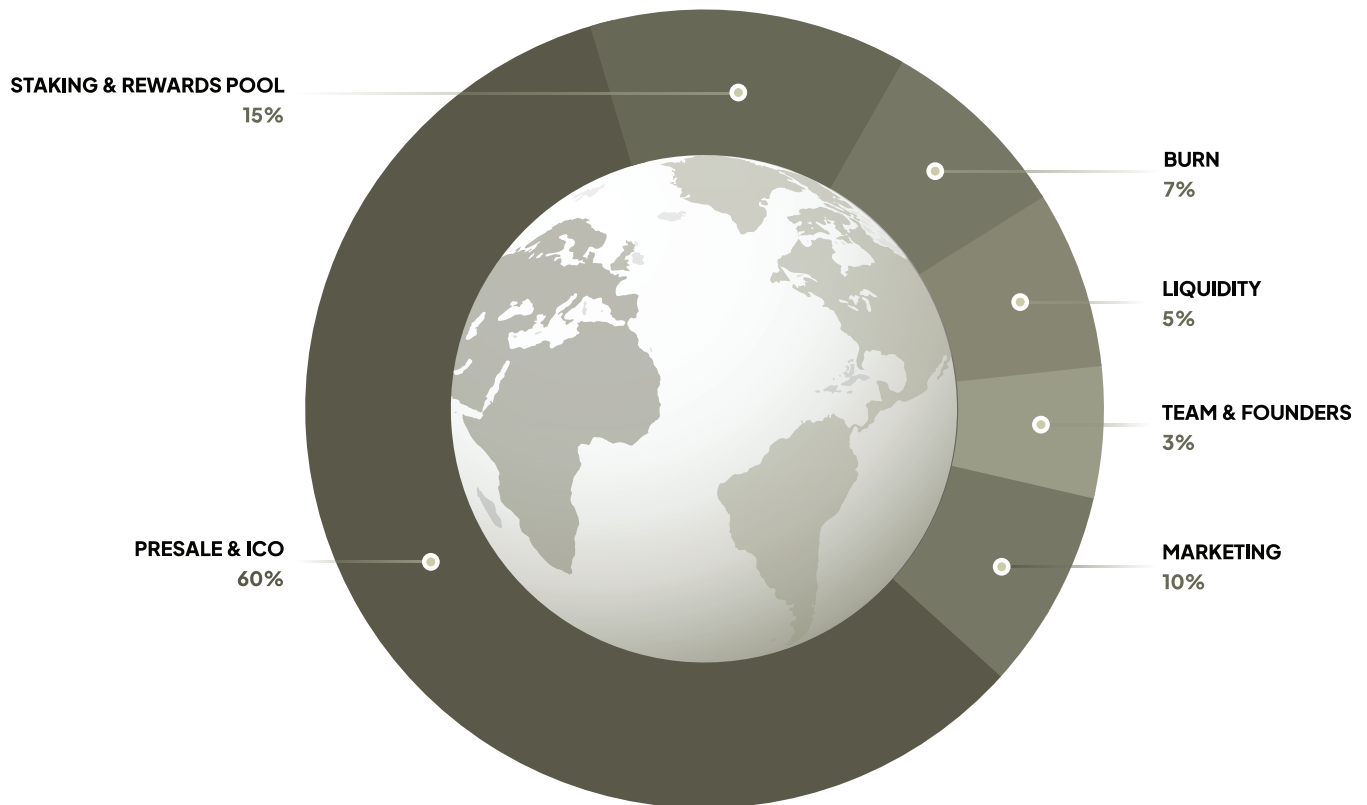
- **Investment Tier Eligibility:** AVLX tokens offer usage rights, perks, and access to rewards.

TOKENOMICS



Avalon X tokens (AVLX) are the foundational utility asset of the Avalon X ecosystem, facilitating investor access, project engagement, tiered investment eligibility, and future ecosystem governance. The total supply is fixed at 2 billion tokens, ensuring scarcity, predictable distribution, and long-term value creation.
